Monthly Reminder to All

From "Everything You Need to Know About Terraverde."

Q. Do I need to regtister my vehicle or vehicles with anyone?

A. You must register your vehicle with the Master Association and with your own unit management association. Call the office for further details. Also your renters or guests must register at the Master Office, or they will not be able to use the amenities until registered.

Q. May I repair my motor vehicle in my carport?

A. No motor vehicle which cannot operate under its own power shall remain upon the development land for more than 12 hours, and no repair of vehicle, except for emergency repairs, shall be made within the development land. All vehicles must have a current license tag and not appear to be abandoned. If your vehicle is leaking oil, please repair it. This causes damage to the carport areas. Turn down boom boxes on your vehicles.

No commercial vehicles allowed in Terraverde parking areas.

JOE INTORCIA'S STEERING MEETING REPORT

IRRIGATION: The east well is down because of an underground electrical problem. There is limited irrigation on common areas. Bids are being requested to tie the common area to the new pump house for future breakdowns, this looks encouraging.

COMMON GROUND: Approval in progress to start new barrier hedges along the front of Island Park Road.

DOCUMENTS: The committee has reviewed the old and new documents thru the summer and continues to do so. Communication from Rey Mayor on 1-4-17 quote, "My lawyer has been working with the Association lawyer and may have reached agreement on the revised docs." end quote.

VACANT LAND: Two realtors have approached me (referred by Rey Mayor) indicating they each have parties interested in purchasing the remainder of our building lots. Rey indicated he has not put them on the market for sale.

In conversation with Rey, I told him there was some interest by a few owners if he would consider selling the property to the owners. He indicated that he would consider any proposal the Association would make to him.

Dee Davis said she has put in several work orders to have the landscaping in front of their building improved and nothing has been done.

Stuart Patrick complained about a hole in back of building #28. He was told to write up a work order. Someone complained about their dumpster and was told that is the responsibility of their building.

Ed from building 22 complained about his friend being fired with no reason given. Someone answered that in Florida no reason has to be given to terminate an employee. Sal noted that the Steering Committee has nothing to do with hiring or firing. Dick, Joe and the Board do that.

Rick from building 15 complained about the recent actions of some residents, wondering who is responsible for taking care of that trend. He asked if background checks are being done.

The question regarding election of Master Board Members and the process involved was discussed and Sal explained the entire process but Rey Mayor has final say since he is still owner.
