JOE INTORCIA'S REPORT:

Clubhouse and Golf: January was a good month. Intake was \$56,489.34 which is about 1/3 of the yearly budget for those line items in the budget. Great work-crew.

Wells: All 3 wells are back in operation. Many repairs are being done on the sprinkler system.

Shrubs: They are clearing the area on Island Park Rd. for new shrubs. Some owners added that they will be 6 foot shrubs and will eventually all fill in to form a shrub barrier.

Audit for 2016: The auditor who did the 2015 audit will soon be starting our 2016 audit.

Street Signs: The signs are here. The delay is due to the old mounting brackets which need to be replaced first. There will also be two Open to the Public golf signs out front, one from each direction. They are being rebuilt.

Turnover: The turnover is a slow process. Our local committee has given their input and the documents are now in the hands of the Master's attorney and Rey Mayor's. The attorneys will work to resolve any remaining issues. Our attorney is aware of the slow process and is doing his job properly and in an orderly manner. During open forum the turnover was again discussed. There are many areas to consider and it will take time to have them done correctly before they are approved. Owners will be given an opportunity to see them before they are finalized.

DICK GAROFANO'S REPORT:

The Valentine's Party was a success, and the Monday and Wednesday meals are going well. Friday night Happy Hours have so much good food there is hardly room for it. There is the

If Rey sells it to a developer, four new buildings can be put up. It has been suggested that Terraverde residents purchase the property when Terraverde is turned over to us to prevent more buildings. The Board has given their ok for an appraisal and Rey indicates we will have the first right of approval.

Candidates for Board of Directors: There are two seats coming up for election. Fran Meyers' term is up and he has indicated that he will run again. Cliff Wright's term is also up and he has elected to not run again. Interested candidates must fill out a form of intent. These are available from Sal DiGrandi. They are due by March. A Meet the Candidates night will probably be held before the next Steering Meeting. Paul Calandra added that candidates need not have any special background or qualifications.

Committee Comments:

Al Day commended our new grounds staff. He noted that for the first time in many years their sprinklers are working correctly. A resident of Building 22 added how the new people are helping them clean up the berms by their building.

Golf Report: Tom Tindall noted that the Ryder Cup is in progress. He also commented on the golf course improvements.
